Classroom Instruction

Changes in classroom schedules will be provided two weeks before the commencement of said changes. The classroom instruction will consist of ten sessions, three hours each session. Students must attend all the sessions of classroom instruction to be given credit for this portion of the program. The sessions are not required to be taken in order, but all them must be completed. Be aware that once the classroom begins, the students will not be able to leave.

Behind the Wheel Instruction

Behind the wheel instruction is generally given in three lessons of two hours each to complete the required six hours of instruction. The behind the wheel instruction is offered after the student receives his/her instruction permit and before his/her 18th birthday. Students are picked up and dropped off from home or school for each lesson (local area only). Only one student will be in the car during the lesson. Lessons can be scheduled by calling our office at (763) 503-4998.

If cancellation of a lesson is necessary, the school must be notified 24 hours in advance. If a student is sick, a note signed by a doctor must be submitted to the instructor or office. If a student misses a lesson without notifying the School 24 hours in advance, there will be a \$50.00 charge.

Contract Expiration & Termination

This contract expires on the student's 18th birthday. All lessons must be completed by one year of date below. If the student requires additional training after one year, a new contract will be negotiated under the Adult Training rate. By law, you are not required to take behind the wheel training at the same location as your classroom training. If you decide to take behind the wheel training elsewhere, you will be refunded \$100.00 of the package price of to one year limit, at which time the contract will expire. Navas Driving School, Inc maintains the right to terminate this contract at any time due to a breach of this contract by the student. Any termination of this contract initiated by the student or parent/guardian of the student may be subject to additional termination fees.
